

SCHIELE MUSEUM NORWAY CRUISE GIVEAWAY CONTEST OFFICIAL RULES

NO PURCHASE NECESSARY TO ENTER OR WIN. NO CONTRIBUTION OR MEMBERSHIP TO THE SCHIELE MUSEUM NECESSARY TO ENTER OR WIN. PARTICIPANTS MUST HAVE INTERNET ACCESS PRIOR TO THE START DATE OF THE SWEEPSTAKES.

ELIGIBILITY: The Sweepstakes is open to legal residents of the United States who are eighteen (18) years or older as of September 1st, 2017. Void where prohibited by law.
